

**1.NAME AND PRINCIPAL OFFICE:**


The name of the Trust shall be **THE EDUNATION TRUST** and the Trust office shall be situated at No.802, 7<sup>th</sup> Cross, 4<sup>th</sup> Block, BEL Layout, Vidyananyapura, Bangalore 560097 (which may be moved from time to time to such other place or places as the Board of Trustees may decide) and the Term Trustees shall mean Trustees of the **THE EDUNATION TRUST** .

**2.TRUST FUND OR CORPUS OF THE TRUST :**

The Founder out of his own caring has set apart and handed over a sum of **Rs.10,000/-(rupees ten thousand)** as corpus of this Trust and handed over the sum to the Trustees and Trustees collectively said (Board of the trustees) acknowledge the receipt of the said sum of

**3.NATURE OF THE TRUST:**

This Trust is Public Charitable Trust, non-profit oriented and irrevocable under any circumstances. It shall be a secular one and its benefits open to all secretions of the society.

**4.OBJECTS OF THE TRUST**

  - (i) Schools, Colleges or any educational institutions in all subjects or fields of knowledge on no profit or loss basis.
  - (ii) Schools, training institutes, rehabilitation centres, classes, workshops, courses, instruction centres, guidance centres for handicapped children (the definition of the word

handicapped being inclusive of disabilities and handicaps of any nature whatsoever, partial of otherwise) either free or otherwise.

- b. To encourage, assist or support financially or otherwise any suitable person/s either recommended by any educational institution or otherwise in the pursuit of his / her academic interests or research projects by paying, reimbursing any fees, charges, tuition fees, charges for boarding, lodging, hostel accommodation etc., or by providing books, educational material and aids, implements or any other similar requirements.
- c. To participate or join or be associated with any person who have objects similar to that of this Trust.
- d. To appeal, call for, request and receive donations from any person both within and outside India in pursuance of and for the purpose of any objects of the Trust and to make, give, gift, contribute or donate amounts, money to other charitable causes, persons, institutions, Trusts, organisations, societies, Government. The term 'person' shall be 'deemed to include Companies, Societies, Trusts, Firms, Association of persons, joint families, Government.
- e. To aid, organise, establish, promote, participate, co-operate with any activity leading to and resulting in relief to the under-privileged, poor, sick, infirm, handicapped, destitutes, orphans, victims of natural calamities and acts of God whatsoever including hospitals, Old age homes, clinics, medical relief centres.

To render financial / other assistance to various institutions which are recognised under Section 80-G of the Income Tax Act, 1961, working in the country for upliftment of poor, handicapped and distressed persons without any bar and to render assistance to the victims of floods, earthquakes, fire, riots or to the Government or private agencies rendering this service.
- k. To do all such other things, either alone or in conjunction with others as are incidental, ancillary, supplemental or conducive to the attainment of the above objects or any of them.

5. The Settlor, along with Trustee shall be trustees for life. The Settlor shall be the President of the Board of Trustees.
6. The Life Trustees shall constitute the Board of Trustees. The Board of Trustees shall have the power to co-opt one or more member of Trustees, if concurred by all the Trustees. All the administrative decisions of the Trust shall be taken by the Board of Trustees.
7. The President of the Board of Trustees who shall preside at all the meetings of the Board. In his absence, the Trustees present shall elect one from among themselves as President of such Meetings.
8. The President shall be in charge of and responsible for the safe custody of all records of the Trust. 9. Without prejudice to the generality of the foregoing objects or purposes and with a view to carrying out the objects of the Trust heretofore mentioned, to augment its funds, administer them and in the discharge of their duties the Trustees shall have the following powers:



- a. To make donations or contributions for the objects of the Trust.

- d. To invest the trust funds from time to time in such securities and in such manner as they deem fit, to alter or vary the investments from time to time to realise the investments, to acquire or to sell securities. The funds of the trust shall be invested in the modes specified under the provisions of section 13(1)(d) read with section 11(5) of the Income-tax Act, 1961 as amended from time to time.
- e. To receive, collect or realise or cause collection or realisation of all interest, dividends, bonuses and premia accrued or due on all or any funds, securities or deeds or documents of like nature.
- f. To execute or negotiate all necessary papers and documents (whether negotiable or non-negotiable), to receive monies and other assets and to grant receipts and discharges.
- g. To represent the Trust in all courts or before any authorities and departments of Government, semi-government or local authority or refer to arbitration the whole or any part of a claim by or against the Trust, to engage lawyers and to take all necessary steps.
- h. To borrow for the purposes of the Trust, with or without a charge and responsibility upon the assets of the Trust.




- i. To meet all the necessary expenses incurred or to be incurred in connection with the creation and execution of this Trust.
  - j. To open, maintain accounts of any nature in any bank or banks of their choice and to authorise operations of the said accounts by any of the Trustees. The trust shall be allowed to take loans from any banking/ non-banking/ financier or any other such persons under market running interest for improvement of the trust.
  - k. To do all other acts, deeds, matters and things that they deem necessary for carrying out the objects of this Trust or its administration.
  - l. To commence, organise, further establish, indulge in, participate in, contribute to any other object or activity of a public and / or a charitable nature.
  - m. The trust shall be entitled to purchase any vehicle for the use of transport of the children/staff/trustee/consultant of the trust.
  - n. The trust will be entitled to engage any company, firms or consultants from time to time to ensure fulfilment of the objects of the trust.
10. The power enumerated in paragraph 10 above, shall be exercised by the Trustees subject to their satisfying the conditions laid down in Section 10(23C), 11, 12 and 13 of the Income- tax Act 1961 as amended from time to time, so that the income of the Trust will be exempted from income tax for such and every assessment year.

11. The management and administration of the Trust properties and affairs thereof shall vest in the Trustees. The Board of Trustees shall have power from time to time to make and alter such rules and regulations with regard the conduct of the business and all matters in respect of duty hereby vested in them, as they may think proper. The Board of Trustees, if they so choose and for the benefit of the trust, may delegate by means of a resolution in writing, any or all of their powers to anyone or more of them or any other person or persons for such time and purpose as they deem fit.
19. The Board of Trustees shall be at liberty to add to or alter or abrogate any of the provisions of the trust apart from the objects of the trust with consent of each other, the stipulation laid down in paragraph 9 of the deed and the provision of section 80G of the Income-tax Act as amended from time to time, enabling donors to win exemption. No amendment to trust deed shall be carried which may prove repugnant to the provisions of sections 2(15), 11, 12, 13 and 80G of the Income Tax Act 1961 as amended from time to time. Further no such amendment shall be carried without the prior approval of the jurisdictional Director/Commissioner of Income-tax.
20. The trustees may reimburse themselves or pay and discharge all the costs, charges and expenses in or about or incidental to the administration or management or execution of any of the trusts or powers of these presents and also all outgoings, taxes, assessments, dues and duties and other taxes payable In respect of trust Income, Trust funds or Trust properties and management thereof and pay all

charges and outgoings payable in respect of any immovable property for the time being forming part of the Trust fund or assets and may carry out repairs which may from time to time be required to be done to the same and keep the same insured against loss or damage as they in their absolute discretion think proper. The Trustees may, be paid remuneration for devoting time and attention to the activities and undertaking work of the Trust.

21. The Trustees shall be wholly indemnified against any expenses and losses incurred or suffered or any payments made by them in the administration of the trust and such expenses, losses and payments shall be borne by the trust and none of the trustees shall in any way be personally liable or responsible for the same.

The Trustees shall be respectively chargeable only for such moneys or securities as they shall respectively actually receive notwithstanding their respectively signing any receipt for the sake of conformity and shall be answerable and accountable only for their own acts, receipts, neglects or defaults and not those of others nor for any banker, broker, auctioneer or other person with whom or into whose hands any trust moneys or securities may be deposited or come or for insufficiency in title or deficiency in value of any Investments nor for any other loss, unless the same shall happen through their own wilful default respectively.

Where the parties fail to reach an amicable settlement of such dispute within a period of 30 days, the dispute shall be resolved by arbitration, conducted in accordance with the provisions of the Arbitration and Conciliation Act.
26. The trustees do not reserve any right to execute will involving the trust property/properties at any time.
27. In the event of this trust being dissolved the properties of this trust shall go to any other trust having similar objectives and which enjoys recognition under section 80G of the Income Tax Act, 1961. The assets shall not be distributed directly or indirectly among the trustees or settler in any circumstances.





